#### Location

River Works is situated on Grange Lane (B6086), in close proximity to the junction with Ecclesfield Road (B6082).

The property forms part of a complex of period industrial buildings in an attractive semi rural location, adjacent to Blackburn Brook.

Whilst being in attractive leafy surroundings is also in close proximity to the M1 Motorway at Junctions 34 and 35.

## Description

The building has brick walls, concrete floor, and a roof of king span insulated panels, incorporating transparent Perspex light panels.

The building has been divided to provide seven individual industrial units. All units have now been let, apart from Unit 6.

Most of the units have either roller shutter or concertina type doors, mains services, i.e. gas electricity and water, and in some cases heating.
