LOCATION

Ashgrove workshops are situated on Ashgrove Road, close to its junction with Stevenston Road (A738), a short distance from the town centre.

Kilwinning Train Station is situated a short walk from the subjects, with frequent service to Glasgow Central departing every 15-20 minutes during the day.

Kilwinning has a population of around 16,000 and situated within the North Ayrshire Council area around 4 miles from Irvine.

DESCRIPTION

The subjects comprise a relatively modern development of 18 light industrial units linked by a central courtyard. There is visitor and tenant car parking.

The buildings are of brick and block construction with mono-pitched roofs clad with profile metal sheeting. Access to the units is provided via recessed double doors protected by a metal roller shutter.

Each unit includes workshop space together with small tea prep area and staff WC facilities. Heating is by way of gas fired wall mounted heaters.

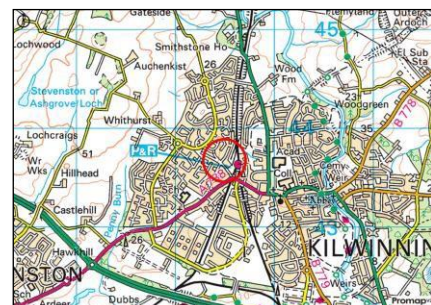
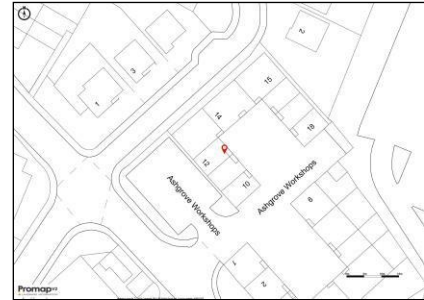
